Report of income for UK tax purposes

Dear Investor,

You are receiving this letter because you were an investor in a reporting share class of the above-named fund on 31 December 2023.

This class of shares are registered with HM Revenue & Customs in the UK as a "reporting fund". As such, the fund is required to make reports of income to the investors. There may be a requirement for you to pay tax as though you had actually received a distribution from the fund.

If you are not subject to UK taxation, you may ignore this notice.
